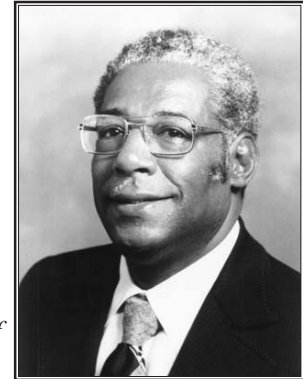

### QUALIFICATIONS:

- The topic for the essay is taken from the Congress theme for the current year.
- Contestant must be entering 11th or 12th grade in the current calendar year.
- Due to the increasing number of students registering for the Oratorical Speaking class, it has become necessary to limit the number of persons eligible for the class. All participants are required to pre-register for the Oratorical Techniques for Public Speaking class (YC5300).
- On-site registration will not be allowed.
- Contestant must be an active member of a participating church represented with the Congress, and no church may have more than two contestants.
- First, second, and third place winners are prohibited from entering the contest more than once.

### PROCEDURES

- All contestants must pre-register for the Oratorical Techniques for Public Speaking class (YC5300).
- Students in the 10th grade may also register for the Oratorical Speaking class for exposure purposes; however, 10th grade students are not eligible to participate in the contest.
- The essay should be a maximum of five hundred (500) words, which is equivalent to five (5) oral minutes. The title, which includes the Scripture and theme, should not be included in the five hundred (500) word maximum.
- The essay must be written by the contestant.
- Four (4) copies of the contestant's essay must be presented Wednesday during class, one for each judge. Orientation and designated time for competition will be given Wednesday, June 16th from 1:30 p.m. - 2:30 p.m. All contestants must be present. The contest will be held Wednesday, June 16th, 3:00 p.m. - 4:30 p.m.; Thursday & Friday, June 17th and 18th, 8:00 a.m. - 10:30 a.m. and 1:30 p.m. - 4:30 p.m. Due to the number of participants and the structure of the course, the instructor may revise the time schedule as needed.
- In order to receive awards or certificates, contestants must be present for the public presentation in the Congress General Assembly on Friday evening at the Charlotte Convention Center. The panel of judges will listen to the reading of the essays and select three (3) to present to the Congress General Assembly.
